Purpose: This document provides a Massachusetts-specific, legally safe pathway for parents, caregivers, and guardians to verify whether public benefits or services were billed, paid, or claimed using their own identity or that of a dependent, and outlines official steps to take when discrepancies are identified.

Introduction

Social media and news reports sometimes describe situations where services appear to have been billed, reimbursed, or publicly funded in a person's name—or a child's name—without the individual's knowledge or consent. In Massachusetts, there is **no centralized public database** that allows a name-based search across all benefit programs.

Records are maintained by administering agencies under state and federal confidentiality laws. The correct approach is **self-verification**: reviewing official records you are legally entitled to access and escalating concerns through formal reporting channels when warranted.

Section 1 – Licensed Child Care Verification (Massachusetts EEC)

Massachusetts licenses and oversees child care programs through the Department of Early Education and Care (EEC). EEC publishes an official searchable directory of licensed child care programs.

Section 2 – Child Care Financial Assistance (Subsidy) and Payments (Massachusetts EEC)

Massachusetts offers Child Care Financial Assistance (CCFA) programs to help eligible families pay for child care and out-of-school time. Subsidy payments may be issued to providers on behalf of qualifying families.

2.4 What parents/guardians should review

- **Eligibility and authorization notices** (approved provider, dates, and any parent fee/copayment).
- **Provider identity** using the official EEC directory (Section 1.1). **[1]**
- **Dates of care** and any mismatch between attendance and what you believe was billed/paid.
- **Ongoing status requirements** as described in EEC assistance guidance (Section 2.3). **[5]**

Section 3 – Health Coverage Claims (MassHealth / Medicaid)

Health services billed under MassHealth (Massachusetts Medicaid) generate formal claims records through plan and program systems. These records are the primary method for verifying whether services were billed in your or your child's name.

3.3 What to check

- Dates of service (were you/your child present?).
- Provider names and locations you recognize (or do not recognize).
- Claims continuing after coverage changes, or after provider changes.

Section 4 – Public Records Requests (Massachusetts Public Records Law)

Massachusetts public records access is governed by the Massachusetts Public Records Law. Personal case information involving minors and medical information may be exempt; however, parents and guardians may request records they are legally entitled to receive and request an agency explanation of any non-disclosure or redactions.

4.4 Recommended records request structure (practical)

1. Identify yourself as the parent/guardian and specify the dependent(s) involved.
2. Specify the program (CCFA, MassHealth, etc.), provider name, and date range.
3. Request “records sufficient to show” payments/claims made on behalf of your dependent for that period.
4. Ask for a written explanation of any confidentiality limitations or redactions applied.

Section 5 – Reporting Suspected Fraud (Massachusetts Official Channels)

Massachusetts provides official reporting pathways for suspected fraud, waste, or abuse of public funds. Preserve your documents first (letters, notices, attendance records, claim summaries, dates).

Section 6 – Public “Red Flag” Patterns (For Awareness Only)

The following markers do not prove misconduct, but they can help families know when to verify records or request clarification:

- **Date mismatch:** claims/payments on days the child was not in care or not receiving the service.
- **Provider mismatch:** provider listed that the family never used.
- **Duration mismatch:** billing continues after termination/withdrawal.
- **Authorization mismatch:** billed hours exceed authorized hours.
- **Identity mismatch:** communications or records referencing a child/dependent you do not recognize.
