Purpose: This document provides an Oklahoma-specific, legally safe pathway for parents, caregivers, and guardians to verify whether public benefits or services were billed, paid, or claimed using their own identity or that of a dependent, and outlines official steps to take when discrepancies are identified.

Introduction

Oklahoma does not maintain a single public, name-searchable clearinghouse for all benefit payments or claims. Records are maintained by administering agencies under state and federal confidentiality rules. The recommended approach is **self-verification**: review official records you are legally entitled to access, then escalate concerns through formal dispute or fraud-reporting channels if necessary.

Section 1 — Licensed Child Care Verification (Oklahoma DHS)

Child care licensing and oversight in Oklahoma are administered by the Oklahoma Department of Human Services (OKDHS), Child Care Services.

Section 2 — Child Care Subsidy (OKDHS Child Care Subsidy)

Oklahoma's Child Care Subsidy program helps eligible families pay for child care. Payments are issued to approved providers on behalf of eligible households.

- Approved provider name and authorized dates
- Attendance versus authorized care

Section 3 — Health Coverage Claims (Oklahoma Medicaid / SoonerCare)

Health services billed under Oklahoma Medicaid (SoonerCare) generate claims records. Reviewing claims history or explanation-of-benefits (EOB) statements is the primary way to detect services billed in your or your child's name.

Section 4 — Public Records Requests (Oklahoma Open Records Act)

Public access to government records in Oklahoma is governed by the Oklahoma Open Records Act (51 O.S. §§ 24A.1-24A.30). Records involving minors or individual benefit/health cases may be exempt; however, parents and guardians may request records they are legally entitled to receive.
