# **Indiana Self-Verification Guide**

## **Detecting Possible Misuse of Benefits and Services in Your Name (Parents, Caregivers, and Guardians)**

**Prepared by:** Tocsin Data

**Date:** January 1, 2026

*Purpose: This document provides an Indiana-specific, legally safe pathway for parents, caregivers, and guardians to verify whether public benefits or services were billed, paid, or claimed using their own identity or that of a dependent, and outlines official steps to take when discrepancies are identified.*

## Introduction

Reports on social media and in news coverage sometimes describe situations in which services appear to have been billed, reimbursed, or funded in a person's name—or a child's name—without the individual's knowledge or consent. In Indiana, there is **no centralized public database** that allows a name-based search across all benefit programs.

Instead, records are maintained separately by each administering agency, under state and federal confidentiality rules. This guide explains how Indiana residents can conduct lawful **self-verification** using official records they are entitled to access.

## Scope and limitations

- This guide identifies where official records exist and how to request them.
- This guide does not allege wrongdoing by any provider or individual.
- Verification outcomes depend on case-specific facts and agency rules.

## **Section 1 — Licensed Child Care Verification (Indiana FSSA / OECOSL)**

Indiana licenses and monitors child care providers through the Family and Social Services Administration (FSSA), Office of Early Childhood and Out-of-School Learning (OECOSL).

### **1.1 Official licensed provider search**

Parents and guardians can confirm whether a provider is licensed using Indiana's official provider portal: <https://childcarefinder.in.gov> [1]

### **1.2 Complaints and compliance concerns**

## **Section 2 — Child Care Development Fund (CCDF) Assistance (Indiana FSSA)**

Indiana administers child care subsidies under the federal Child Care and Development Fund (CCDF), providing payments to eligible providers on behalf of qualifying families.

### **2.1 What parents can review**

- CCDF eligibility and authorization notices
- Approved provider name and service period
- Copayment obligations, if applicable

### **2.2 Official CCDF parent information**

### **2.3 If discrepancies are suspected**

Parents may contact their assigned caseworker or submit inquiries through FSSA regarding authorization or payment inconsistencies tied to their child's care.

## Section 3 — Health Coverage Claims (Indiana Medicaid / HIP)

Health services billed under Indiana Medicaid or the Healthy Indiana Plan (HIP) generate formal claims records. These records are the primary source for verifying whether services were billed in a child's name.

### 3.2 What to check

- Dates of service
- Provider identity
- Services billed after eligibility ended

## Section 4 — Public Records Requests (Indiana APRA)

Indiana's Access to Public Records Act (APRA) governs public access to records, while still protecting confidential personal and medical information.

### 4.1 APRA overview

Indiana APRA is codified at Indiana Code § 5-14-3. General public guidance:

Requests involving CCDF or child care programs should be directed to FSSA using agency FOIA/APRA procedures.
