Purpose: This document provides a Kansas-specific, legally safe pathway for parents, caregivers, and guardians to verify whether public benefits or services were billed, paid, or claimed using their own identity or that of a dependent, and outlines official steps to take when discrepancies are identified.

Introduction

Reports on social media and in news coverage sometimes describe situations in which services appear to have been billed, reimbursed, or funded in a person's name—or a child's name—without the individual's knowledge or consent. In Kansas, there is **no centralized public database** that allows a name-based search across all benefit programs.

Instead, records are maintained separately by each administering agency, under state and federal confidentiality rules. The practical solution is **self-verification**: reviewing official records you are entitled to access as a parent/guardian, and escalating concerns through official complaint and fraud reporting channels when warranted.

Scope and limitations

- This guide identifies where official records exist and how to request them.
- This guide does not allege wrongdoing by any provider or individual.
- Verification outcomes depend on case-specific facts and agency rules.

Section 1 – Licensed Child Care Verification (Kansas KDHE)

Kansas child care licensing information and public compliance search tools are provided by the Kansas Department of Health and Environment (KDHE).

Section 2 – Child Care Subsidy / Assistance (Kansas DCF)

Kansas child care assistance is administered through the Kansas Department for Children and Families (DCF), Economic & Employment Services. These programs can result in payments to providers on behalf of eligible families.

2.3 What parents/guardians should review

- **Eligibility and authorization notices** (approved provider, dates, and any family share/copayment).
- **Provider identity and compliance status** using the KDHE compliance search (Section 1.1). [1]
- **Dates of care** and any mismatch between attendance and what you believe was billed/paid.

Section 3 – Health Coverage Claims (Kansas KanCare / Medicaid)

Health services billed under Kansas Medicaid (KanCare) generate formal claims records through plan systems. These records are the primary source for verifying whether services were billed in your name or your child's name.

3.1 KanCare clearinghouse contact (official)

3.2 What to check

- Dates of service (were you/your child present?).
- Provider names and locations you recognize (or do not recognize).
- Repeated claims after eligibility ended, or after provider changes.

3.3 If you find a claim you believe is incorrect

- Request the claim detail and dispute steps through your managed care plan, using the KanCare clearinghouse contact as a starting point. [5]
- Consider reporting suspected Medicaid fraud via official Kansas channels (Section 5). [6]

Section 4 – Public Records Requests (Kansas Open Records Act / KORA)

Kansas public records access is governed by the Kansas Open Records Act (KORA). Personal case information involving minors or medical services may be confidential; however, you can request records you are legally entitled to as a parent/guardian, and request an agency explanation of what can be disclosed.

4.3 Recommended records request structure (practical)

1. Identify yourself as the parent/guardian and specify the dependent(s) involved.
2. Specify the program (child care assistance, Medicaid, etc.), provider name, and date range.
3. Request “records sufficient to show” payments/claims made on behalf of your dependent for that period.
4. Ask for a written explanation of any confidentiality limitations or redactions applied.

Section 5 – Reporting Suspected Fraud (Kansas Official Channels)

Kansas provides multiple official fraud reporting pathways depending on the program involved. Preserve your documents first (letters, notices, attendance records, claim summaries, dates).

Section 6 – Public “Red Flag” Patterns (For Awareness Only)

The following markers do not prove misconduct, but they can help families know when to verify records or request clarification:

- **Date mismatch:** claims/payments on days the child was not in care or not receiving the service.
- **Provider mismatch:** provider listed that the family never used.
- **Duration mismatch:** billing continues after termination/withdrawal.
- **Authorization mismatch:** billed hours exceed authorized hours.
- **Identity mismatch:** communications or records referencing a child/dependent you do not recognize.
